1. The length of your boat should include bowsprits, swim decks, boarding ladders, stern drives, outboards, rudders, anchors, pulpits & any other extensions fore and aft of your boat.
2. Allocation of berth is at the discretion of the Marina Management. Priority will be given to existing holders.
3. The fixing of matting to pontoons or the walkway is not permitted under any circumstances.
4. Pontoons & Jetties can be extremely slippery. Caution is required at all times.
5. Tenders must be declared and registered with the office, any not abiding by this rule will be removed without notice. Tenders will be allocated shallower berths not necessarily next to your boat. They must also be insured.

Tenders are charged separately and we must be informed of there make and registration number. All tenders under 10FT are charged at £300 + VAT (Calculated at the time of payment). All tenders not registered or declared will be removed **without** notice.

2011 Marina regulations are displayed on the marina notice board or a copy is available on request from the park office.

The company reserves the right to charge a £25 Inc VAT launch/recovery Fee.

ANY PREVIOUS BERTH HOLDER NOT PAYING THE DEPOSIT BY 31.12.2010 WILL AUTOMATICALLY RELEASE THIER BERTH FOR REALLOCATION.
